Bidders should have completed, within **two (2)** years from the date of submission and receipt of bids, a contract similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of the Republic Act (RA) 9184, otherwise known as the Government Procurement Reform Act". Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for the eligibility provided in the IRR of RA 9184.
4. Interested bidder may obtain further information from Saint Anthony Mother and Child Hospital and inspect the Bidding Documents at PPS office Monday to Friday; 8:00am to 5:00pm.

A complete set of Bidding Documents may be acquired by the interested bidders from **March 6, 2017 to March 28, 2017** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **twenty five thousand pesos only (Php 25,000.00)**.


