1. The Saint Anthony Mother and Child Hospital, through the General Appropriations Act and/ or continuing appropriations 2016, RA 10717 intends to apply the sum of One million four hundred thousand pesos only, to wit:

2. The Saint Anthony Mother and Child Hospital now invites for the Re-bidding for Supply and Delivery of Various Medical Equipment. Delivery of the Goods is required for a duration of SIXTY (60) calendar days. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of the Republic Act (RA) 9184, otherwise known as the Government Procurement Reform Act". Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for the eligibility provided in the IRR of RA 9184.
4. Interested bidder may obtain further information from Saint Anthony Mother and Child Hospital and inspect the Bidding Documents at PPS office Monday to Friday; 8:00am to 5:00pm.
5. A complete set of Bidding Documents may be acquired by the interested bidders from April 24, 2017 – May 16, 2017 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of five thousand pesos only Php 5,000.00).


